

## ACPE Board of Directors' Report

#### May 3-6, 2015 Atlanta, Georgia

The ACPE Board viewed a Live Text demonstration. The Accreditation Commission is conducting a pilot project with the software. Currently, there are 27 Centers participating. Initial feedback is positive and the Commission intends to move forward.

The Professional Development Task Force, Certification Reform Task Force and the International Relations Task Force updated the Board on their work. The conversations are still preliminary and no decisions have been made. The Task Forces will continue their dialogue with the Board and the membership and bring proposals to the 2016 meeting.


The condos at 1549 Clairmont Road sold for over \$300,000. The money is being invested. Interest and dividends will offset the lease at the new One West Court Square office.

The foundation hired Jasmine Terry Okafor as a Development Specialist at the national office a few months ago. She is working with Trace Haythorn, Executive Director to learn more about raising money for an association.

Stu Plummer is the new president of the ACPE Foundation. Nancy Anderson is the chair-elect. Robin Brown-Haithco continues as secretary and Ted Hodge as treasurer. Ute Schmidt is this year's annual campaign chair and Biju Chacko is chair-elect. The Foundation has created term limits and continues to recruit new members with a focus on diversity.

Warren Averett CPAs and Advisors, in consultation with our new accountants Kolb & Jones, conducted an audit which included all of the Regions and the Foundation. For the first time, we have a clear picture of the health of the entire ACPE association. The Board adopted recommendations from the auditors to streamline our processes, create more transparency and provide more security.

The fees for Clinical Members were reduced to \$100.00 starting in 2016. Clinical Members are needed on Accreditation Site Teams as the Clinical Practitioners.

The 2016 Standards & Manuals were approved. They will be published with a new software on the website. The software will allow us to link all the sections of the manuals to each other.

The Governance Task Force conducted two surveys of the membership this year. The surveys provided hundreds of pages of feedback. The Task Force continues to collate and evaluate the data and feedback.

Additionally, the Governance Task Force recommended two consulting firms to help guide the Association through an organizational design process. Tecker International from Yardley, PA, will meet the Task Force, the Board, and members at the 2016 annual conference in Denver, CO.

After evaluating the results of the Conference Strategic Initiative Task Force report, the suggestion is to allow the national staff to plan the logistics/business and have the revamped Academy choose the programming in consultation with the local planning team. The national conference will meet in Denver (2016), Minneapolis (2017), Atlanta (2018), Phoenix (2019), Minneapolis (2020), and Atlanta (2021). Conference funding with the Regions will be coordinated through the national office and our ACPE Foundation.

### **REGIONAL DIRECTOR'S REFLECTIONS**

### **Things Are Moving**

As children, my brother and I would occasionally say we were "*bored*" because there was nothing to do especially during summer breaks from school. My grandmother who had a comment for most everything would say in response, "*don't you say that. Time goes too fast. It will be over before you know it.*" Well to

a 12 year old that made little sense. From my vantage point of this place in my life, she was of course right — AGAIN. I suppose what I learned from her was to let no grass grow under my feet and to always look for some new adventure. Fortunately I've had little trouble staying busy. But that may have left me not being more reflective when I should have been. So here's a little reflecting from where I sit.



CPE as an educational model is basically 100 years old. It doesn't seem possible. And what's more startling to me is that I've been a part of many of those years and spent virtually my whole professional career involved in clinical pastoral education in one form or another.

Looking back I'm prompted to see what I've learned. Looking foreword I'm prompted to wonder what might be next. Part of that prompting

simply comes from looking at the calendar. Part of the prompting comes from seeing the great energy ACPE and its leaders are putting into planning its next 10-30 years. Frankly I'm very glad we're doing this work. Hopefully some part of this little reflection will prompt you to engage the conversation that is going on.

As educators we have always voiced our deep commitment to learning, change, novelty and experimentation when it comes to ideas, principles and clinical practice. But what has intrigued me for decades is our inability as an organization to actually explore, innovate and step out of our old molds. We say we want to develop new programs and educational options. Yet as I think about the last 40 plus years, I see people pulling back or being overly cautious when something new is suggested or times force us to change direction. I've often said to colleagues that every time ACPE has a challenge or crisis, it ultimately employs the same strategy to solve it. We abandon discussing the real issue and start meddling with our polity, our governance. I guess we believe that fixing how many representatives we have on the Board or the number of members on some committee will protect us and manage the real problems. I've always thought that was odd for a group claiming to be innovators. That response hardly sounds innovating. Yet I think that's what we've done.

I wonder what prompts us to trust tinkering with governance as a solution to changing healthcare policies, students wanting to utilize social media, institutions that are demanding greater productively and community/institutional leaders asking for research that confirms our "felt" claims to know something is healing and helpful. Frankly I don't see what's so appealing about governance conversations when these other areas seem so much more interesting and vitally important to our profession and our calling. I think my grandmother would encourage us to stop having the same old stodgy, boarding conversation that doesn't move us anywhere, and to get on with the work that can actually draw us into the future in meaningful ways.

I only know a small portion of what is being discussed in the many appointed work groups from the ACPE Board. One thing I do know is that for the first time in a very long time we're looking at all the issues, genuinely exploring new avenues and considering options for our professional practice we have been hesitant to engage. Yes we're discussing governance. But we haven't stopped there. It seems to me we're looking at the real issues in new ways that might move us forward. Thanks ACPE Board and our leaders for taking this step.

The work groups have been challenged to present their work by the time of 2016 national conference in Denver . In the Mile High City in that rarefied air we will all hear the reports of the work done and join the conversations about the future of our enterprise that brings the diverse, large ideas together. We have the chance to not retreat to polity discussions and fail again to address the pressing matters. We have a chance to wonder why processes that are intended to be fluid, open and embracing have become so rigidly sacred that we cannot discuss them without blame and rancor. Remember last spring?! We have a chance to wonder out loud what is the nature of adult spiritual care education in the 21st century. We can inquire of colleagues of all ages, cultures and backgrounds how we can actually leave a legacy that will endure another 100 years and serve people far beyond where we are today. Now that's not boring. Grandma would approve I think.

Having read Anton Boison's work, I am convinced he had no idea we would still be using his material 75 years after he wrote it. Like many of us, he was caught up in his work and the small group of learners before him. That's easy to do as we all know. I suppose we can blindly continuing doing what we've always done. In other words, we can do what my grandmother call *"foolishly boring"*. Or we can embrace this time and the future to which it points to truly offer a profession of significance to those looking for a challenging, meaningful career, an association worth embracing and a calling to service that will be as life giving for others as it has been to many of us. Personally I think that's our duty to do that. From my view we have no right to think we can set that duty aside. I'm thankful to the ACPE President and Board for launching us on this journey.

I hope you will familiarize yourself with the ACPE conversations going on. I hope you will offer ideas, perspectives, models of education and styles of religious service that are new, fanciful, energizing, on the edge and yet practical enough to be put into the service of others. I look forward to seeing you all in the lofty heights of Denver as we create a new and vital spiritual care and education organization.

## News You Need to Know

- 1. If your Center has a <u>TEN YEAR REVIEW</u> pending, remember that site visits are to be completed by the end of October of each year. Consult with the Regional Chairperson about dates and national Site Team Chairs.
- 2. A Center is allowed <u>ONE EXTENSION IN ANY 10 YEAR ACCREDITAION CYCLE</u>. Once used for either the 5 or 10 year review, there are no other options for extending.
- 3. Any and <u>ALL CHANGES to YOUR PROGRAM or CENTER</u> are to be reported on <u>Appendix 2</u> in the <u>Accreditation Manual</u>. Changes include: adding/amending contracts, name change, certification status of staff, faculty changes, and adding/deleting components/satellites.
- 4. The <u>2016 STANDARDS</u> were approved by the Board and will be published soon. See ACPE Board Report.

### Peer Review

Congratulations to the 10% of the supervisors who have completed their Peer Review process this year! Please do not hesitate to contact any of the Peer Review Committee members if you have any questions or concerns about doing your Peer Review. All documents, forms and information can be found on the region's website.

Earlier this year the committee was able to add to a conversation that ACPE was having related to Peer Reviews. The focus group, directed by our ACPE president, was reviewing various peer review practices across the regions. They were familiar with our practices in the Pacific Region. We shared with them that there are two values that guide our process: collegiality and consultation. We believe that these two principles develop a healthy community of supervisors and encourage an environment where open and honest consultation becomes a regular practice by our supervisors. We often get inquiries from retired supervisors asking if they can continue to do them, to which we respond with a resounding "YES!".

We shared that we realize there are some limitations by focusing on these two principles. For example, we do not have or require a quality standard. Our committee's review of the submitted documents does not judge how the supervisor used the consultation. The national subcommittee was reviewing peer review processes that also addressed values missing in our process: consistency and objectivity, quality and intentionality.

We relayed that over the past couple of years we have had dialogue with our regional board about how to maintain these values while addressing the following concerns:

- 1. How to support supervisors who do not participate at their scheduled peer review or are not invested in their process;
- 2. Addressing the gap between our peer review processes and other member groups in the Spiritual Care Collaborative which also have peer review processes for their members to maintain professional standards.

We made two recommendations to the sub-committee: I.We would like to see our ACPE Peer Review Process be more consistent with the other Spiritual Care Collaborative member groups' peer review processes. 2.

Peer Review and any re-certification process be kept separate.
